The usage of the GAGE trails is authorized to the undersigned upon the following terms and conditions:

1. **THE UNDERSIGNED HAS PROVIDED THIS DATE PROOF OF LIABILITY INSURANCE COVERAGE ON THEIR POWER CART.**
2. The undersigned assumes all risks and losses to property (including his/her machine or property) and injury to himself/herself or other persons arising from the use or storage of the machine or ancillary equipment and the GAGE RECREATION CENTRE expressly disclaims any liability whatsoever arising out of the operation or storage of said machine or ancillary equipment in the custody of the undersigned.
3. The undersigned agrees to indemnify, protect and save harmless GAGE RECREATION CENTRE from and against any and all claims and demands for damages of property and injury to persons which may arise out of the operation or storage of said machine or ancillary equipment while in or out of the custody of the undersigned.
4. The undersigned represents that he/she is familiar with the operation and safe control of a golf cart and will abide by the following rules:
  - a. he/she accepts the conditions and location of the cart paths and will stay on these paths for the safe operation of the cart and will use bridges where provided;
  - b. he/she will follow any signs posted concerning cart paths;
  - c. he/she will stay at least 30 feet from greens or tees unless on a prepared cart path;
  - d. he/she will not operate the cart with any more than two persons and two golf bags in the cart;
  - e. Juniors: 5 to 7 years of age – Can ride as a passenger but must stay in golf cart.  
8 to 15 years of age – Can golf and ride as passenger  
16 years and Older – Can golf and drive a cart
  - f. absolutely no personally-owned alcoholic beverages to be transported or carried onto the course, other than that sold by the vendor; and
  - g. golf carts cannot be loaned or operated by any individual other than the undersigned except in the case of husband/wife.
  - h. Also cart owners are only permitted to have the same passenger ride with you two times during any given week. For persons riding 3 or more times there are supplementary plans that can be purchased.
5. The undersigned agrees that the term of this agreement shall be from 01 May until 31 October. The undersigned further agrees that he/she shall remove the golf cart and any ancillary equipment no later than one week after the course closure.
6. Failure to abide by these rules and Regulations can result in the loss of trail fee privileges.
